Board of Directors Meeting Minutes | Tuesday, January 18th, 2022 | Via Zoom

Call to order: The meeting was called to order at 8:03 a.m.

Approval of Minutes: Russ moved to accept the minutes from February 15th, 2022. The motion was seconded by Rolf and passed unanimously.

Executive Director's Report - Lyle Jepson

Lyle introduced and welcomed Olivia Lyons, our new Communications and Marketing Manager. Lori Pinkowski has been hired as our Office Manager and will start next week. Lyle introduced Jon and Zak Hale from Hale Resources. Jon and Zak highlighted some of the work they've been doing developing sustainable, quality housing in Southern Vermont, mostly in the Bennington area at this point. They've been talking about moving their developments into Rutland for a few years now, and they feel like now is the right time. They've built a great operation with a great team and investor partners, and they're looking to buy and renovate a portfolio of properties in Rutland. Their focus is on market-rate but all income levels are accommodated in their business model. They have extensive experience working with NeighborWorks, using the VHIP program to bring around 60 units online in the Bennington area, along with other housing partners using a variety of resources and incentives (historic tax credits, CDBG, etc.). They have been looking at potential sites and properties for redevelopment. They would prefer a 30-50 unit portfolio in the area to start as they get to know the market and local vendors, and they are looking to identify owners interested in selling. They would not exclude scattered sites. The Hales emphasized they don't want to step on anyone's toes and appreciate the opportunity to meet people and get the lay of the land.

Real Estate Committee

The committee met with Jon and Zak Hale to discuss developing housing in the Rutland region.

Marketing Committee

Mary Ann welcomed Olivia to the team and expressed her excitement in the transition, and reported Kim set up the transition nicely to allow for seamless operations of the marketing and concierge programs.

Finance Committee

Karen referred to the minutes and indicated it was a quick meeting to review the financial reports and discuss an exit strategy from a problem loan as the loan balloons this March. We have seen a number of loan inquiries this month but none have resulted in an application.

Events Committee

Eric reported we are beginning to schedule events, with the Feud scheduled for April 30th and a mixer scheduled for April 14th at the Rutland Rec Center. We are looking to schedule the Whoopie Pie Festival and Parade of Heroes on August 27th.



Business Development Committee

Russ reported the committee covered a lot of topics this month, with most of the activity centered around The HUB, where 501c3 formation and grant writing are currently taking place. The committee discussed the development of a TIF district in Killington, the redevelopment of the CSJ campus, development of Phase II of the Airport Business Park, Zion Growers and their interest in the Marble Museum building in Proctor, regional priority projects, and the launch of the Community Navigator Pilot Program.

Policy Committee

Tyler reported our regularly scheduled committee meeting was not held this month in place of the Legislative Breakfast which was held virtually on Monday, February 14th, at 8:00 a.m. with around fifty people in attendance.

DEI Committee

Shana reported the committee has identified several action steps and they will meet again on February 25th to prioritize and determine the next steps. The committee will start developing relationships with entities that have a DEI mission and has invited Mia Schultz of the NAACP to attend the meeting. The committee presented the DEI strategy to the board for approval.

Motion: Russ moved to accept the CEDRR DEI Strategy as presented by the DEI Committee. The motion was seconded by Mike and passed unanimously.

Old Business

Lyle thanked the board and the committee members for their service to the organization, as a staff as small as CEDRR's would not be able to do all the work we do without the support of the board and committees.

New Business

Lyle encouraged the directors to attend the mixer on April 14th.

Real Estate Committee Meeting Minutes | Wednesday, March 2nd, 2022 | Via Zoom

The meeting was called to order at 8:03 a.m. Approval of the previous minutes was tabled due to a lack of quorum.

Hale Resources / CSJ Updates

We had Jon and Zak Hale from Hale Resources present to the CEDRR board at their February meeting, prompted by their presentation at the last Real Estate Committee meeting. Jon, Zak, Tyler, and Brennan toured the CSJ campus extensively, and this has kicked off an ogoing conversation with the Hales, the RRA, and various housing organizations to look at redeveloping the CSJ campus into mixed use housing. Mary Cohen and Lyle met with Senator Leahy's office in an effort to find money for a feasibility study for CSJ redevelopment. Multiple parties have expressed interest in CSJ.

Rutalnd Airport Business Park Phase II Update

We met with the officers of the Airport Business Park Board to determine possible funding streams to fund the infrastructure development needed for Phase II of the Park. The officers wish to proceed with grant funding that will lead directly to project implementation. Tyler will work with the State on the Northern Borders Regional Commission grant process, with the next step being bringing the full Park board together to get everyone on board with pursuing funding. The NBRC applications open in the coming weeks. Lyle reported the Airpor Committee has started meeting again, with major topics being the process of building a new hangar at the airport and marketing the airport.

USDA RD RBDG

We've been meeting with Elizabeth Kulas to discuss funding long-term capacity at CEDRR to have more hands-on ability to see major commercial property development projects through to completion. Elizabeth is working with the Vermont Farmer's Food Center, M&S Development, and others to redevelop the VFFC property and potentially other surrounding properties, and we'll be shadowing this effort to learn more and replicate the process.

Fair Haven Distribution Hub

Joe Gunter, the Fair Haven Town Manager, is pursuing the development of a regional manufacturing/agricultural hub facility that would be connected to rail and assist producers in multiple regions access broader markets.

Old Business

Rutland City has approved using \$400,000 of the City's ARPA money as grant match for The HUB. On April 14th we're holding a mixer where we will tease the grand opening of The HUB.

New Business

We need to reach out to encourage more committee member involvement in this committee.

The meeting was called to order at 11:32 a.m.

Staffing Introduction

Lyle Jepson introduced Lori Pinkowski as the new Office Manager for CEDRR. Lori told the group about her background in marketing and events, and being from the Rutland area. Lyle introduced Greg Youkov, CEDRR's website designer. Lyle introduced Olivia Lyons as CEDRR's new Communications and Marketing Manager, she talked about coming from WCAX and being back in her hometown.

Weekend Getaway

Lyle says all requests from towns have been approved, so it is important to continue promoting what they have to offer. Lyle says Vermont is working on substantial funding to do their own marketing and part of it will filter down to us. Funding is not a done deal.

Concierge Volunteers and Meet Up

Real Rutland is looking for more volunteers. Olivia shared she and Bethany Sprague are working on a meet-up for concierges and marketing may change to keep people who moved here, here.

Other

Brennan Duffy suggested a mixer at Killington, asking the Governor to talk about Rutland and Vermont to capture those who are here for the weekend to ski and ride. Bill says Brandon is working on an Electric Fest for July 9th, press will begin next week. Lyle told the committee the Rutland City Board of Aldermen will match funds for The HUB and the governor is also adding matching money in his budget. CEDRR mixer at the Rec Center on April 14 will reveal The HUB. Kim is excited and telling people to save the date.

Finance Committee Meeting Minutes | Tuesday, March 8th, 2022 | Via Zoom

The meeting was called to order at 8:17 a.m. Approval of the minutes was tabled due to lack of a quorum. Lyle introduced Olivia and Lori and welcomed them to the staff.

CEDRR Internal Financials

The committee reviewed the financial reports including the CEDRR P&L, balance sheet, and regional marketing activity. While we continue to show gains month-to-month in our financial reports, Lyle and Tyler will be working with Seward to gain a better understanding of our overall operational financial health. As we continue to expand programs and marketing, we want to get a better sense of what money is encumbered and how different areas of activities are performing to get a more complete picture of the overall organization, particularly as our programming expands rapidly.

Revolving Loan Fund

All loan clients are current on payments except for loan #108-01-01. The committee discussed loan #108-01-01 and the ballooning of the loan scheduled for March 15th. The committee asked staff to produce an amendment to the loan agreement extending the balloon for 60 days. The committee suggested adding cross-default language to the amendment so a default on our loan reflects a default on all the loans in the financing arrangement – the other lenders would need to sign this amendment, and Tyler will reach out to the other lenders first to give them a heads-up. We should also consider producing a form for the borrower to sign binding the borrower to use any SBA EIDL loan money the business receives towards paying off our loan first, as a part of the amendment. Deb will send Tyler example language for this amendment. Loan #108-01-01 is behind on February's payment, and being current on all payments is a condition of granting this extension.

Old Business

New Business

Lyle encouraged the committee members to attend the CEDRR mixer on April 14th and the Real Rutland Feud on April 30th. Lyle announced the opening of the Hub is being planned for June, the City has approved \$400,000 and the Governor's budget has approved \$166,000 in grant matching funds for the Hub, and area businesses and individuals continue to contribute. Deb announced the People's Bank merger is moving fowrard. The next meeting is scheduled for Tuesday, April 12th, at 8:15am.
