Board of Directors Meeting, Tuesday, June 20, 2023

The meeting was called to order at 8:16 a.m.

Approval of minutes: Nicole made a motion to accept the minutes of the May 16, 2023 meeting. The motion was seconded by Daniel and passed unanimously.

Real Estate: 112 Quality Lane: All of the leases for the tenants in the building end on April 30, 2024. Ann Clark has indicated an interest in continuing with their lease. The MINT has an opportunity to partner with Rutland Area Robotics and expand into more space in the building. They have entered into a sublease arrangement with Bodycote starting July 1_{st} for 11,920 square feet. The MINT is requesting a letter of intent that CEDRR will continue with a lease at \$3.50 per square foot beginning on May 1, 2024, which is a reduction in the rate we are getting for the space currently. Under this scenario, The MINT will vacate the 3,786 square feet they are currently occupying, which Ann Clark will then take over on July 1_{st} , 2023. Although granting The MINT a lease at their continued reduced rate for additional space will generate less revenue in the future than had been previously budgeted, the building will continue to be a productive real estate asset for CEDRR. It is recommended to the Board for approval of a 3-year lease for The MINT on May 1, 2024, for \$3.50 sq/ft NNN, creating a new lease for Ann Clark for additional space beginning July 1, 2023, and creating a one-year lease with Bodycote beginning May 1, 2024.

Bill made a motion to approve the signing of the letter of intent between The MINT and CEDRR as presented. The motion was seconded by Daniel and passed unanimously.

Executive Director Report: President of Resort Residential at Great Gulf, Michael Sneyd, was introduced by Lyle. Michael gave an overview of Great Gulf and his background in working on resort development projects and specifically Killington Village. Great Gulf was started in 1975 in Canada and is currently developing properties in 19 cities across North America. The goal of the Killington project is to build upon services that are already in place and create spaces conducive to families. In partnership with the town, Great Gulf is seriously considering helping with workforce housing in Killington.

Finance: The committee reviewed the finances for the month, and it was a strong month with grant funding being drawn down. That funding will support StartUp Rutland costs, primarily. The Finance Committee has discussed moving funds to a higher interest-bearing account, which Tyler will research. Karen, Lyle, and Tyler have had interviews with two people for the Finance and Compliance Manager position. There is currently one incomplete application to the revolving loan fund. The applicant is waiting to hear back from other potential financing sources before submitting a final application.

Business Development: See Real Estate report above.

Marketing: Olivia reported that the Mini Mountain bike weekend took place this past weekend for two people. Unfortunately, a second couple didn't visit because flights were cancelled. Going forward, we will change the model back to families who are serious about relocating and must interview for eligibility. The Fall weekend getaway is moving forward. Marketing for that will start in two weeks and the event will take place on October 12-15.

Events: The committee has reviewed its existing events to determine if they were profitable and to look at how to minimize expenses and maximize revenue. Instead of adding more events, the committee is looking at ways to add value and revenue to current events. Chrispin has had conversations with Oliver Subaru and is looking into a raffle for a 3-year lease. The goal would be to sell tickets at CEDRR events and then draw a winner at the Annual Meeting in November.

The last Mixer at Cluckin' Café was a success, and the owners were very happy. The next Mixer is July 11th at Four Seasons Sotheby's.

Policy: The final legislative breakfast was June 5th, where the Governor was in attendance. The next meeting will be in September.

DEI: The committee met with organizers from Rutland County Pride to make a connection with organizations in the community. CEDRR donated \$1,000 to the Rutland County Pride Festival. The Festival was well-attended, with Rutland County Pride reporting an audience of approximately 3,000-4,000 people.

112 Quality Lane Update and Site Visit

Kim gave us a tour of the new space at The MINT. The transition is ongoing as equipment and tools continue to get resituated but much work has been accomplished. The wood and metal shops are completely separated, allowing for a better use of space and addressing the safety concerns arising when the two spaces were collocated. The new entryway is more comforting and inviting. There is a new computer lab paid for by a grant and put together by a cohort of Rosie's Girls – both youth and adult programming will occur in the lab. They are changing their approach to renting out studio space, standardizing the spaces instead of letting people pick how much square footage they need – they will build walls for this, and they currently have two interested parties in these spaces. iBots had a camp going this morning – this is an example of how the partnership with Robotics will allow The MINT to level up their offerings. They expect to have the Robotics arena built by September 1st. Sponsorships and other fundraising will be necessary for The MINT to sustain the new space. The committee looked at the south parking lot – Nicole is continuing to work with Coca-Cola on a solution but it is moving in a good direction, and work should be able to be completed in the Fall.

The meeting was called to order at 11:33 a.m.

Notes from Olivia:

Weekend Getaway 2022

We spent \$2,800 on social media ads, but we also spent money on Google ads. 450 people entered. 4,605 links clicked from the social media ads, bringing people to the Real Rutland website. 356,731 people (about half the population of Vermont) reached on social media. The campaign ran for 28 days.

Weekend Getaway 2023 – October 12-15

We will spend \$1,500 on social media ads and no money on Google ads. 621 people have entered as of Wednesday afternoon. 4,623 links have been clicked from the social media ads, bringing people to the Real Rutland website. 428,393 people have been reached so far. The campaign will continue until August 11, running for a total of 39 days. Interviews will continue until August 25. Winners will be announced on August 29. 89 interviews have been scheduled, but not everyone shows up. Olivia follows up with each person and sometimes they reschedule with her. Currently, Olivia has interviewed 15 families and says there are about half a dozen quality contenders. Many are young 20-30s couples who want to start families in Vermont.

As of Wednesday afternoon, someone from every state except, Alaska, Iowa, New Mexico, Utah, and Wyoming have entered. Yes, there was one Vermonter from Springfield. The length of time might be a little long, Olivia thinks the shorter campaigns, around 28 days, are better.

Mountain Bike Weekend Getaway

We spent \$1,400 on social media ads. About 600 people entered, this was an open-ended entry, people were not required to interview or discuss relocating to the area. 3,102 links clicked from the social media ads, bringing people to the Real Rutland website. 297,378 people reached on social media. The campaign ran for 29 days.

We are looking for ideas for the following portions of the weekend getaway:

- Where to host the welcome dinner on Thursday, October 12. Last year, we held it at Still on the Mountain, and it was nice, but expensive. We held the mountain bike weekend getaway at The Lookout, could we use the upstairs area for an event? Any other ideas?
- Does anyone know of any events or activities happening that weekend?
- We are thinking about potentially cutting costs by not hosting the dinner on Saturday and asking everyone to go to a meet & greet (next topic) instead. We will still host the breakfast on Sunday morning where we can get feedback and learn what went well and what should be modified.
- Any activities we didn't do last year that people would suggest? We hosted the following activities, kayaking, rock climbing, guided hike, suggested hikes, scavenger hunt (on their own), mountain biking, and the Hathaway corn maze. We planned the art tour and the covered bridge tour, I think a few drove by some of the bridges in their travels, but no one took part in finding all. The Poultney Chili Fest was also the weekend we hosted last year. It is September 30th this year.

Meet and Greet Collaboration

Arwen Turner, Executive Director of Come Alive Outside (CAO) asked if we would like to host a welcome party for new residents at the October 14, Leaf Peeping Party, outside of Roots. This is the same weekend as our Weekend Getaway, which we think is perfect. The families will be invited as well to show them how our community truly welcomes people in, and they will be able to meet people, get resources, and purchase Rutland and fall items.

Arwen has since invited the Downtown Rutland Partnership, CEDRR, Green Mountain Approach, and other CAO affiliates to take part in the planning. Olivia has volunteered to be at the meeting when a time is set, and we are determining how we will be involved financially. More information to come.

The analytics have not been completed because Google was not giving accurate statistics and Olivia didn't want to share false numbers. We will have them soon and share them once it is up and running again. Example, it said no one had visited the website in over a week, which is obviously not true.

Concierge Coordinator Update

Karly provided the following information:

- Number of new Rutland County residents this year (through 8/1) through the Concierge Program: 36
- Number of people who will be moving to Rutland county by the end of 2023: 22
- Number of people moving to Rutland county in 2024: 8
- Bringing the total of people who have moved using the Concierge Program since 2016 to approximately 225.
- We are going to exceed 2022 numbers.
- The total number of new Rutland County residents through the Concierge Program in 2022 was only 39 people.

Other

On 10-14-23 there is a community-wide yard sale that might be fund for the Weekend Get-A-Way.

Both Jordan and Sarah reported that visits to Vermont and local businesses are down, in large part because of the flooding and perception that Vermont is not open. We discussed messaging on Real Rutland that Rutland County is open for business.

Sarah pointed out that Olivia did a great job presenting at the VCRD conference about Real Rutland, where there was great interest. Kudos to Olivia!

The group met at the MINT, Rutland's Makerspace. The meeting was called to order at 8:18 a.m. Kim Griffin, Executive Director of the MINT, provided a tour. A new computer lab is being utilized by a wide spectrum of citizens from seniors to younger participants. She outlined youth learning opportunites that have taken place over a five-week 40 hr/wk timeframe. A Rosie's Girls program was currently underway at the time of the visit.

Kim indicated that the MINT started relocating shops on July 1st, the point in time when the MINT took over a larger portion of the building. It is a work in progress that will culminate in a MINTacular event in October as part of the Art Hop event that takes place throughout the County. It will be a two-day event, with the bulk of the MINT's delivery on the Saturday of the targeted weekend. Marketing materials will be broudly distributed.

Kim pointed out that membership is growing, they have a very active team of volunteers, and they are excited by the new relationship that they are developing with Rutland Area Robotics. A clear continuum of education, training and participation is providing opportunities to elementary age individuals to adults.

Committee members were impressed with the MINT's progress and current offerings. Kim acknowledged that the MINT will always be in transition as it works towards meeting the needs of the community.

When asked what she needed for support, Kim indicated that marketing the existence and opportunities available is essential, and she welcomed any help in doing so.
