The meeting was called to order at 8:02 a.m.

Approval of Minutes

Mark Foley, Jr. moved to accept the minutes from September 18th, 2018. The motion was seconded by Michael and passed unanimously.

Executive Director's Report

Tyler introduced REDC's Assistant Director, Kim Rupe. The board welcomed Kim to the team. Tyler reminded the board that the REDC Annual Meeting is in two weeks. REDC will be awarding Awesome Graphics and Casella Construction with the REDC Businesses of the Year awards. Two students from Stafford Technical Center will also be awarded the Young Innovators of the Year award for their second-place medal at SkillsUSA for Additive Manufacturing. The Rutland County Parent Child Center communication is attached to the board packet regarding updates on the progress of the cleanup and Tyler noted that the November 1 deadline is quickly approaching. The Young Professionals Summit of Vermont is on October 27 in downtown Rutland and all are welcome. The event will include tours of downtown Rutland and will be more interactive than in the past. Erin updated the board on Real Careers @ Rutland County, which is being led by Program Coordinator, Michelle Heitkamp. Michelle has two full classes, one at Otter Valley and one at Mill River. Each class is well-engaged, and the students show a wide variety of career path interests. Michelle has the students going on weekly field trips including, GE Aviation and a visit from Robbie Stubbins. Kim updated the board on the recent Vermont Talent Pipeline Management (VTPM) meeting in Berlin on manufacturing. Kim noted that the manufacturing employers there, including Carris Reels from Rutland County, were engaged and provided data and feedback for the VTPM team.

Entrepreneurship Committee

The committee met with The MINT Operations team to work on their presentation to the board, which was scheduled for the October meeting, but the committee opted to have them reschedule. The committee thought it would be a better plan to have The MINT spend a few more months preparing for their presentation to the board. There were a few surprising items for the operations team to discuss with the committee. Membership has dropped from around 60 to 23. The MINT needs better structure in place to be sustainable. Tyler, John R., and John C. are going to help them with a presentation, fundraising structure, and business plan over the next few months. The sustainability struggle and growing pains are not uncommon among makerspaces and REDC is committed to helping The MINT be successful. The committee will keep the board informed.

The 10-week business planning course with the Center for Women & Enterprise (CWE) is continuing and has 13 students enrolled. Mentors are participating in class and will be assigned students at the end of the 10 weeks. The CWE regional CEO visited to thank the mentors and meet REDC.

Policy Committee

The committee reviewed the experience at the structured listening sessions and is drafting a letter on the joint committee's perspective on the event and ways to support the Act 250 Commission's work going forward.

Finance Committee

The committee approved a loan application and reviewed the quarter 4 financials. REDC staff is preparing for the annual audit. REDC is still working out a few accounting protocols with Valente & Seward but they have been easy to work with. There is an abundance of money for REDC to loan out in the future.

Real Estate Committee

The committee met at The MINT this month and is in full support of the makerspace along with the Entrepreneurship Committee and REDC's Board of Directors. The Quality Lane building is functioning well and just has some small pieces of fall cleanup.

Marketing Committee

Year two of the Regional Marketing Initiative was unveiled at the Chamber's annual meeting with a great response from the crowd. Mondo is starting to roll out the story-telling videos of Real Rutland'ers on social media. There will be a mix of videos and photos across the digital platforms. The board is encouraged to see the new Real Rutland website at www.realrutland.com.

The next Stay-to-Stay weekend is this weekend, October 19 to 22. There are 12 people coming. Wendy Knight is pleased with the program and hopes it will be funded again next year. The community is invited to the welcome reception on Friday, October 19 from 6:30 to 8:00 P.M. at Southside Steakhouse.

The meeting was called to order at 10:35 a.m.

Presentation and Update from Downs Rachlin Martin

Joe Choquette and Trey Martin of Downs Rachlin Martin presented updates to the joint policy committee following the 2018 election and looking ahead to the 2019 legislative session. Joe also announced his upcoming retirement at the end of the year. Trey will continue to represent the RDCs across the state and will be our primary point of contact.

Joe and Trey reviewed the statewide election results surrounding the governor, lieutenant governor, house, and senate races. The major takeaways from the election included, the democrats gained a supermajority and the house has veto power. They noted that there is now a diverse caucus, there will be new challenges for house leadership, and RDCs might find new challenges in defining meaningful collaboration opportunities. There were very little changes to the senate.

The legislative issues that present common themes include a distrust of the federal administration, a focus on economic development and workforce development, and water quality funding.

Governor Scott's priorities continue to be controlling spending and taxes, growing the economy, and protecting the most vulnerable.

The issues the legislature is facing in 2019 are paid leave, minimum wage, water quality, Act 250, chemical regulation, workforce development, costs of energy, Act 46/school consolidation, child care, marijuana regulation, and outdoor recreation or rural economic development.

The group thanked Joe and Trey for their time.



Real Estate Committee Meeting Minutes Wednesday, November 14th, 2018 67 Merchants Row | RRPC Third Floor Conference Room

The meeting was called to order at 8:02 a.m.

Approval of Minutes: Mark F. moved to accept the minutes from October 10, 2018. The motion was seconded by Jerry and passed unanimously.

Quality Lane Update

Ellison's lease is up at the end of 2021 and they have two additional five-year options. Ellison seems satisfied with the space and has put money into redesigning the front office space. The committee will update the board on the terms of the lease. REDC will continue to keep a close eye on the lease going forward to share with the committee as well as the full board.

Opportunity Zones

Jim provided the committee with some updates from his research on Opportunity Zones. Jim noted that the process seems more complicated than we originally thought but more information should become available in the next few months. The Rutland Herald building is the type of property that could be a good fit for investment opportunities. The opportunity fund could also invest in shares and partnership interest. Jim noted that 75% of Rutland is an Opportunity Zone. RDCs will be important in getting the word out and connecting projects with funding. Once a few projects happen in Vermont, it should become easier. There is a 180-day period to commit the capital from an Opportunity Zone fund that could be detrimental in Vermont, but the committee needs more information on whether that 180-days is just for the money to be moved or the project to be completed.

REDC will be important to help ensure that barriers do not get in the way of projects going through. The committee would like to continue to discuss to figure out how to best facilitate and attract capital to our region. The committee will also focus on gathering the proper metrics to attract key investors while also focusing on improving our region's aesthetics in concentrated areas around the downtown and surrounding neighborhoods. The group will continue to discuss the strategy for approaching opportunity zones in our region at the next meeting.
